## Underwriting

It's the process of evaluating a risk

- Does if fit within underwriting appetite?
- Review of operations, policies & procedures, historical loss experience
- Determine coverage terms (i.e. limits, exclusions)
- Pricing

## **Liability Claim Process**

I have been sued...now what?

- 1. Notification to Insurer (via Broker)
  - Timely Reporting Important
- 2. Assignment of Claim Examiner / Defense Counsel
  - Coverage Determination
  - Duty to Defend
  - Reservation of Rights
- 3. Investigation & Evaluation
  - Legal Liability
- 4. Negotiation/Settlement/Trial
